The term "household" is based on the number of adults living in the home. Children under the age of 25 living in the home or away at school are part of the household but not counted as an adult for this purpose.

The Continuity Fund, which all new members are assessed, is used to maintain and improve the Temple's physical plant and properties. This assessment may be deferred until the oldest member of the household attains the age of 35, and may be paid over a five year period. A 10% discount will apply if paid in full when first due. New members over age 60 may select any Temple fund they wish to endow.

At Temple Beth Torah, any individual or family interested in joining our congregation should have the opportunity to do so. No one, therefore, will be denied membership for financial reasons. Those needing financial assistance should contact the Temple President in confidence.
